<b>Tax-deductible amount</b> (gift amount less tangible benefits: \$200 per guest)	\$3,000	\$8,000
<b>Missouri state tax credit</b> (50% of tax-deductible amount)	(\$1,500)	(\$4,000)
<b>Net cost</b>	\$3,500	\$6,000
